1. Setup/Breakdown: All vendors must be set up and ready to sell by 9:45AM, the day of the event. Set up times: Friday night 6 to 9 PM or beginning at 6 AM the day of the event. Non-Food vendors must be breakdown by 9 PM day of event. Food vendors must breakdown by noon on Sunday. Before leaving please make sure your area is clean and trash free.
2. Staffing: Vending booths must be manned at all times. The Huntingdon County United Way is not responsible for merchandise and equipment.
3. Vendor Responsibility: Vendor will be fully responsible for any loss and damage to their property by theft fire or casualty. The Huntingdon County United Way expressly disclaims responsibility for the same. Vendors shall be responsible for any damage which may be incurred to the facilities as a result of or in connection with its operations. Each vendor is responsible for the conduct of its employees.
4. Vendor Spaces: Spaces are reserved at a first come first served basis. Vendors must stay within their allotted space, which includes rails, stands, and additional equipment.
5. Acceptance: The Huntingdon County United Way reserves the right to decline any application and space if it deems such action to be in the best interest of the event.
6. Payment: Due with the submission of this form.
7. Tables & Chairs: Each vendor is required to furnish their own tables and chairs. Non-food vendors will be inside, no tents will be needed. Food vendors will be outside, and are required to furnish their own equipment.
8. No alcoholic beverages are permitted on the premises.
9. No pets of any kind are permitted on the premises.
